

SCI Electric Public Company Limited (Company) recognizes and respects the privacy of personal data (as the definition given below), the company therefore has created a Personal Data Protection Policy ("This Policy") to explain how the company and/or group of companies treat your personal data ; such as data collection, data usage, disclosing, including your rights, etc. We have established a privacy policy which covers the methods we collect, use, disclose, transfer and store your data.

The definition

The Company	means SCI Electric Public Company Limited
Group of companies	means any juristic person in which the Company is a majority shareholder, directly or indirectly, in that juristic person or the company has the power to control or manage whether by being a majority committee in that juristic person or by contract or otherwise.
You	means Website users
Data Owner	means Person who owns personal data
Person	means Individuals
Personal Data	means information about a person that makes it possible to identify that person directly or indirectly in accordance with the Personal Data Protection Laws.

In order to comply with the Personal Data Protection Act B.E. 2562 and other related laws both currently in force and which will be amended in the future. The company would like to inform you that the company has collected your personal data on our website as necessary for the purpose of the company. We therefore ask your consent before collecting such data. The company will keep your personal data in a safe and appropriate way.

Collection of personal data

1. To collect and store personal data, the Company and/or Group of Companies will use legal and fair methods to collect and store data as well as collecting and store personal data as limited as necessary under the objectives of the company and / or the group of companies only.
2. The Company and/or Group of Companies will request the consent of the data owner before collection, unless ;

- 2.1 In the case that the law requires.
- 2.2 For your benefit and requesting consent cannot be made at that time.
- 2.3 For the benefit of the life, health or safety of the data owner.
- 2.4 For the benefit of the investigation of the inquiry official or the trial and adjudication of the court.
3. The Company and/or Group of Companies will not store personal data involved the Genetic Sexual behavior or information that may be harmful discredit or may cause unfair feelings of discrimination or inequality for any person except ;
 - 3.1 Receiving a written consent from the data owner.
 - 3.2 In the case that the law requires.
 - 3.3 For your benefit and requesting consent cannot be made at that time
 - 3.4 For the benefit of the investigation of the inquiry official or the trial and adjudication of the court.

The company may collect your personal data via the website or by phone via the following channels.

1. When you contact us for information, the company may request your information; such as your name, email, telephone number.
2. When you fill out information to receive news from the company or ask about other matters.
3. Log files “refers to website traffic data files” is information about communication of computer systems represents the origin, source, destination, route, time, date, quantity, duration, type of service or others related to computer system communication. Using the company's services through the website www.sci-mfgr.com or Group website. Access data and during the use of service is recorded automatically, which can be linked to such personally identifiable information such as IP Address, which is used as the linked data return to internet connection information which may specify the origin of the post or the person who posted it including websites that go in and out before and after and the type of web browser program.
4. Cookies means small information that a website sends to the owner of information who visits the website to help the website remember the information of each owner, such as the first language chosen of system user or other settings. When the personal information owner visits the website next time, the website will remember that it is a user who has used the service.

Then, the website will be set according to the personal information owner until the owner of the personal information deletes the cookies or disallowing those cookies anymore. The owner of personal information is able to accept or not accept cookies. In the event that you choose not to accept or delete cookies, the website may not be able to serve or display correctly.

In this regard, the company will use the information that cookies have recorded or collected to use in statistical analysis or in other activities of the company In order to improve the quality, further increasing the convenience of visiting your company website for you.

The company may use the information service provided by third party service providers. In order to process the storage of personal data in which the company will select an appropriate service provider and strictly comply with personal data agreements.

Limited use of personal data

1. The Company and/or Group of Companies will be able to disclose personal data only with the consent of the data owner and must be used for the purposes of the company and / or the group of companies only.
2. The Company and/or Group of Companies will ensure that the officers do not reveal, display or make appear in any other manner personal data other than objectives or to third parties except ;
 - 2.1 In the case that the law requires.
 - 2.2 Receiving a written consent from the data owner.
 - 2.3 For the benefit of the investigation of the inquiry official or the trial and adjudication of the court.
3. In some cases, the Company and/or Group of Companies may allow other people or organizations to access or use personal data as necessary and in accordance with the objectives and authority of the company and / or group of companies. However, the consent of the data owner must be obtained before.

Rights of personal data owners

1. Have the right to request access to their own personal data.
2. Have the right to request to amend or change their personal data to be completely correct.
3. Have the right to suspend use or disclose their own personal data.
4. Have the right to request removal or destroy their own personal data.
5. Have the right to request disclosure of their own personal data. In the case that the information is not given to the consent of the collection or storage.

However, the company and/or group of companies may deny the rights of data owners in the event that the law required or in the event that personal data is made to appear no more identifiable.

Changes to Personal Data Protection Policy

The company and/or group of companies may update this policy from time to time to reflect changes in the operations of the company and / or the group of companies without notifying the owner of personal data in advance. We therefore encourage the owners of personal data to read this policy every time they visit the company and / or group of companies' websites.
